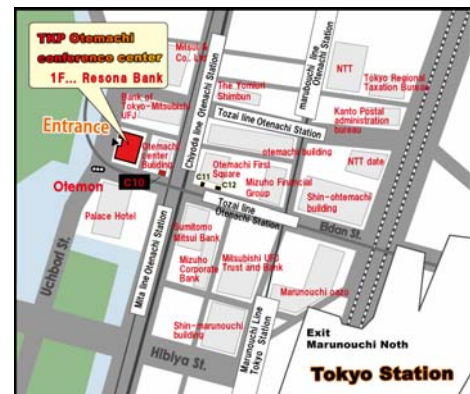

Global Cartel Seminar

February 17, 2010 (Wednesday) | TKP Otemachi Conference Center | Tokyo

Quite recently, The Japan Fair Trade Commission announced that they would establish a permanent staff of investigators specializing in international cartel in the fiscal year commencing from April 1, 2010. In response to this action, please be informed that we have changed the seminar details below for the global cartel seminar.

The theme of the seminar has been updated and is now called, “Dealing with international cartel investigations – How to avoid or minimize exposure”.

The seminar will address issues such as the following below:

- Critical issues regarding cartel policy (i.e. if they are controlled or prohibited, the civil and criminal consequences, immunity/leniency capabilities and settlement options)
- Current trends and accelerating risks in the antitrust/competition law industry
- Past fines, penalty charges and surcharges in Europe, the US and Japan
- Key elements of compliance policies
- How competition problems and companies suspected of international cartel are discovered
- How to handle international cartel cases (i.e., the difference between proactive and reactive approaches)
- Leniency issues with regards to Japan, the US, Germany, Italy, France, Australia, Brazil, Mexico, Canada, South Africa, Singapore, Switzerland and draft leniency policy in India
- Global areas under internationally unified policies – Needs of utilization on leniency system for countries
- Dealing with international cartel investigations– How to avoid or minimize exposure and coordinate for audits

About two years ago in 2008, Baker & McKenzie established a Global Cartel Task Force within our Global Antitrust & Competition Group consisting of four members, in order to study the issues and coordinate the teams of cartel practices in handling the rapidly changing world of international cartel enforcement issues. All four of the members of the Task Force committee, Fumio Koma (Asia Pacific region), Douglas Tween (US region), Ross Denton (Europe region) and Francisco Todorov (South America region) will be in Japan together with Shinichiro Abe of the B&M Tokyo Antitrust Group to lead the lectures for the seminar.
